3 IT IS HEREBY ORDERED:

- 4 1. This Chapter 11 case is converted to a case under Chapter 7 of the Bankruptcy Code;
- 5 2. The State of Washington's Motion to Appoint a Chapter 11 Trustee and The Motion to  
6 Shorten Time & Strike Portions of the State's Reply to Responses to Motion to Convert  
7 filed by Carolyn A. Lake are moot; and
- 8 3. The Clerk of the Court shall provide notice of the conversion of this case to the Debtor, all  
9 creditors, and other parties in interest.

10 The Court defers ruling upon the State's Motion to Record the State Court Judgment in *State v.*  
11 *Eyman*, Thurston County Superior Court, Case No. 17-2-01546-34 in Snohomish and King  
12 Counties pending evaluation by the Chapter 7 Trustee.
